 - Did not meet

- b. Graduate Associate Deans Committee (*Cabot Zabriskie*)
 - Did meet in October
 - Bulk of meeting about disciplinary actions
 - i. Streamlining process, same for grads and undergrads
 - 1. 4 phases, time frames that stages need to happen by
 - What to do with grad students?
 - i. 1 credit dissertator status, almost universally disliked
 - 1. grad students wouldn't take 1 credit seriously
 - 2. students should be able to in order to limit fees and costs
 - ii. summers are only full time with 9 credits
 - 1. per federal government regulation?
 - 2. Trying not to make it go into effect until next summer
 - 3. 5 is part time
 - iii. Main directive, protect PhD production
 - iv. Q: US Dept of Ed might be the ones requiring these changes?
 - v. Q: What does this mean for people who are teaching? – should be able to teach, but check with your department
 - vi. You are supposed to get a syllabus for any courses you sign up for

 - Met in October
 - Newsletter from OGEL (sent 10/21)
 - Grant workshops are being offered, link for signing up
 - College tuition was brought up, they'll keep trying
 - Parking rep was there – rec center, grad after hours parking
 - i. Suggested to allow department sharing as some students may only need it one night a week
 - Morgantown would institute 2 hour paid parking spots, no plans for WVU to do the same
 - Town hall did not have a good turn out – need to get the word out better for the next

 - i. First 2 meetings with full senate
 - ii. Budget finalized
 - 1. \$127,000

- a. Increasing Cost to Graduate Students (Meetings with College Deans)

- When to schedule? – January, mid to late
 - Developing Talking Points
 - Karraker sent a letter to deans with talking points
 - How college tuition is being spent within the college?
 1. How is it allocated among the different depts? Equally? By student?
 - How is it used to enhance graduate education?
 - Explain questions in advance so they can provide answers
 - What is fee structure? Were new students aware of costs?
 - Most (Davis) not aware of use of college fees (450)
 - Davis has high number of GAs, college really helps grad students
 - CCA most not aware of use of college fees (550)
 1. Not much discussion about it
 - Nursing (900), lots of costs for supplies and labs
 1. Paid beyond base stipend
 2. Classes online, makes it difficult to reach all the members
 - Engineering (621)
 1. Funding for student conferences?
 - Stadler response was raising stipend to make up for rise in tuition (not a transparent policy)
 - Law (7000 per semester for college tuition), no separate fees for the college listed
 1. Lots paid for by college
 - Medical fees? Dental school fees?
 - Maybe flyers around campus to reach more people
 - Main points
 - Push for transparency about how they use the college tuition handed back to them
 - Push for transparency for incoming students to explain true cost of attendance
 - Information on our website or OGEL about fees and where the funds go, maybe before March/April
 - Meeting Logistics
 - Revisit in December?
